**ASSOCIATE** This membership classification is \$125.00 per calendar year and is not prorated. Individuals living in Boone, Audrain, Callaway, Cole, Moniteau, Cooper, Howard and Randolph counties DO Not qualify for an Associate membership. It does not require paying the initiation fee. **This membership provides full range and membership privileges but does not include the right to vote.**

All membership applications are subject to a background check, review, and approval by the Board of Directors. Payment of applicable membership dues and fees will be due when you complete your orientation and receive your range pass. **You must also include a copy of one of the following: a copy of a Federal Form 4473 (completed by FFL) within the last 12 months, a current Concealed Carry Endorsement, a current FFL, a current letter from a law enforcement agency stating you are not a felon, or call the Missouri Highway Patrol for a Name Search (573-526-6153).**

All members are required to learn and abide by the range safety rules and operating procedures and to accept responsibility for their own safe conduct and that of their guests. Applicants must also complete an orientation program.

By signing this application, the applicant states he/she is at least 18 years of age, able to lawfully possess firearms in the state of Missouri and is currently a member or has applied for membership in a National Gun Rights organization such as the NRA. He/she also states that all information provided on this application is true and acknowledges that any false information will result in immediate termination of membership without refund.
